#### New Protocol on Vaccinations in the SCA

- SCA Board of Directors issued a new protocol for requiring proof of vaccination or a negative COVID test within 72 hours of the SCA activity. - The Middle Kingdom has decided to enact the Society protocol on requiring vaccinations or negative COVID tests for all participants over 12 at all SCA activities. Please see the Society requirements and FAQs at the end of this newsletter. In addition, Kingdom has issued a statement that can be found here: https://midrealm.org/blog/2021/10/01/covidsafe-procedures/ It includes the following clarifications:
  - $\circ$  The people verifying vaccination/test status at each activity must be warranted officers, marshals, or heralds.
  - At this time, children under 12 must wear a mask at all times (including outdoors) at SCA activities.
  - No record of vaccination or test status may be kept do not indicate the status on the attendance list in any way as these records are kept and might be shared.
  - Anyone who verified vaccination/testing status must sign the declaration (item #7 in the Society protocol document) along with the time they were actively checking. A form has been created for this purpose that can be found at the end of this document and here: https://bit.ly/3ouacUd
- At the end of the activity, the signed declarations are to be sent to the Kingdom Seneschal, while the
  attendance list is still kept by the local seneschal. Kingdom has set up a form where you can upload a
  photo of the signed declaration form after every event, found here: https://bit.ly/3D7ZKpz
- You may give both the attendance and signed declarations to the local seneschal, who can send a copy of the signed declarations to Kingdom. Or, a person may be designated by the seneschal to send the signed declaration via the Google form. Attendance records should still be kept by the seneschal.

### Random Period Object - Cleveland Museum of Art



Inscribed Tombstone of Shaikh al-Husain ibn Abdallah ibn al-Hasan (died 1110); Iran, early 12th century

Limestone;  $\sim$ 425.5 x 40.2 x 16.75 inches in size

Calligraphy, considered the supreme art form in the Islamic world, covers this tombstone. Verses from the Qur'an form the border and central arch. Within the niche are the name of the deceased, the year of his death, and the names of the carvers (Ubaydallah Murra and Umar).

More work survives by those artists than by any other working in the area at the time. However, they only collaborated on 3 other pieces.

## **Book Review - "Henry VIII and the Art of Majesty: Tapestries at the Tudor Court"**

King Henry III owned one of the largest collections of royal tapestries. But centuries later, most of it had been destroyed or passed out of royal hands. For that reason, tapestries from that time have not received much attention from historians. Author Thomas P. Campbell seeks to correct that in his 2007 book "Henry VIII and the Art of Majesty: Tapestries at the Tudor Court."

Anyone interested in the workings of the Tudor court or 16th century textiles will be delighted by this scholarly and thorough book filled with images of gorgeous tapestries. At 400 pages, most readers will flip through this book rather than absorb every page, but will come away with greater insights into the roles of textiles and art in court life.

While an inventory of Henry VIII's collection following his death listed about 2,450 tapestry wall hangings - including more than 300 sets of three or more tapestries all on the same theme - more than 95% of the collection was destroyed or dispersed between 1547 and the early 1800s, Campbell writes.

"By the time that respect for the tapestry medium recovered in the mid- to late 19th century, only about 30 items from the Tudor era remained in the collection," Campbell writes. "These pieces survive today at Hampton Court."

The earliest royal textiles belonged to Queen Isabella, mother of Edward III, in the 14th century. Edward appointed a member of the court to care for his tapestries and wall hangings, an office that lasted for centuries.

During the Tudor period, these wall hangings were valued as a medium of artistry, propaganda, and courtly splendor. Their subjects ranged from allegorical and chivalric to heraldic, mythological, and religious.

They also added insulation and color to drafty castle interiors.

Best of all, they were portable, which was important for royal households that were constantly on the move from one castle to another. They could stand up to being rolled up and carted away to be hung up in a new location before the king and his entourage arrived. Castle walls were equipped with permanent hooks to hold the tapestries, Campbell writes.

Tapestries are made by weaving with colored threads, usually wool. Weavers in the Netherlands were able to produce a broad range of textures and colors by using fine interlocking areas of color, as well as different materials and techniques. The effect made the finest tapestries look as detailed and lifelike as a painting.

Tapestries were copied from a full-scale sketch of the final design, called a cartoon, painted on linen or paper. Before starting a project, the weaver traced the cartoon onto the bare warp threads.

A skilled weaver could produce a high-quality tapestry at a rate of half a square yard per month, Campbell writes. Gold thread - actually silk thread wrapped in a thin gilt filament - went into the finest pieces.

"Only the richest members of society could afford high-quality sets of gold-woven tapestries, and it was for this reason that tapestry became a fundamental part of court display," he said.

The SCA Board of Directors aims to balance getting Society participants back to doing the things we love with measures that support Kingdoms in protecting all that people have worked so hard for. Our COVIDSafe Resolutions provide a flexible, risk-based framework that allows Kingdoms in the United States and Canada to put in place a core set of requirements that event organizers and attendees must adhere to, based on their current environment and public health directions and advice.

As more information becomes available, the Board reviews and updates its resolutions in line with its responsibility to act diligently, with due care, and in good faith. This is never more important than with issues related to the health and safety of our fellow participants. In line with this approach, based on changing circumstances and updated expert advice, on September 25, 2021, the Board has resolved the following:

#### **Proof of Fully Vaccinated Status Or Negative COVID Test**

In addition to the existing policy allowing Kingdoms to establish a mask policy, Kingdom Seneschals in consultation with the Crown shall have the discretion to implement the following policy requiring proof of COVID vaccination or a negative COVID test taken within 72 hours of an event start time from all event attendees:

- 1. Events are any activities defined in Corpora II.A, Society Events Defined.
- 2. Proof of being fully vaccinated must be in form of a government issued card (original or photograph) or an electronic record.
- 3. Proof of negative covid test must be issued from a licensed medical provider and presented in such paper form or electronic form that the event staff can verify its authenticity. Letterhead from a medical provider or an email address clearly identifying the medical provider as the sender of an electronic record shall constitute authentic proof.
- 4. All persons over the age of 18 must present government issued photo identification along with the proof of being fully vaccinated or a negative COVID test. Parents and guardians of minors must present their own identification along with proof of being fully vaccinated or a negative COVID test for all minors attending an event in their care.
- 5. Proof of vaccine or a negative test shall not be required for children under 12. Children that are aged 3 through 11 shall wear a mask.

- 6. In addition to the normal sanctions process, anyone challenging event staff regarding the enforcement of this COVID policy shall be denied entry to or be immediately removed from the event.
- 7. The Kingdom must have one person at a time checking the proof of being fully vaccinated or a negative COVID test at an event. The event organizer, or their designee, shall maintain a list of names and times of the person(s) conducting the check at the entrance. Once the entrance is closed at the event, said person(s) will sign a statement at the bottom of the list of names and times, which reads:

"I have monitored the event entrance at the times noted above, and I have verified that each person entering the event during that time to have shown me proper identification, along with either proof of being fully vaccinated or a negative COVID test taken within 72 hours of the start of the event."

The event organizer, or their designee, shall forward the signed statement to the Kingdom Seneschal, or their designee, who shall maintain such records in accordance with the standards for retention of waivers.

- 8. Kingdom Seneschals shall notify the Society Seneschal where local, state, provincial, or national law supersedes this policy.
- 9. This policy shall not apply to Lochac and Drachenwald.

For the last number of months, the Board has received an increasing amount of feedback from Kingdoms and individuals about the option to require vaccinations or negative covid tests for participation. Who is considered fully vaccinated?	People are considered fully vaccinated after receiving the full series of a COVID 19 vaccine or combination of COVID-19 vaccines approved by the World Health Organization (e.g., two doses of a two-dose vaccine series, or one dose of a single-dose vaccine series).  In general, people are considered fully vaccinated: ±  2 weeks after their second dose in a 2-dose series, such as the Pfizer, Astra Zeneca or Moderna vaccines, or  2 weeks after a single-dose vaccine, such as Johnson & Johnson's Janssen vaccine  If you don't meet these requirements,	
	regardless of your age, you are NOT fully vaccinated.	Implementation
